



## BANCO SAN JUAN INTERNACIONAL TERMS OF USE FOR MIDI APP

These terms of use are entered into by and between you ("Customer," "you," "yours," or similar terms) and Banco San Juan Internacional, Inc. ("BSJI," "us," "our," or similar terms). The following terms and conditions (the "Terms of Use"), govern your use of the mobile application owned by MIDI Technologies LLC and licensed to BSJI (the "MiDi App") and any products or services offered by BSJI through the MiDi App ("Products") or by a third-party provider that we make available to you through the MiDi App ("Third Party Services"). Your acceptance of these Terms of Use is required to use the MiDi App and to obtain any Product or Third-Party Service offered on the MiDi App.

BY ACTIVATING, DOWLOADING, OR USING THE MIDI APP, YOU (A) ACKNOWLEDGE THAT YOU HAVE READ AND UNDERSTAND THESE TERMS OF USE; (B) REPRESENT THAT YOU ARE 18 YEARS OF AGE OR OLDER/OF LEGAL AGE TO ENTER INTO A BINDING AGREEMENT; AND (C) ACCEPT THESE TERMS OF USE AND AGREE THAT YOU ARE LEGALLY BOUND BY ITS TERMS. IF YOU DO NOT AGREE TO THESE TERMS OF USE, DO NOT ACCESS OR USE THE MIDI APP AND DELETE IT FROM YOUR MOBILE DEVICE (AS DEFINED BELOW).

### 1. GENERAL

Please note that your use of the MiDi App, including for example the provision of any depository account services through BSJI, is subject to additional terms and policies for that Product or Third-Party Service. In the event of a conflict between these Terms of Use and the terms of any Product or Third-Party Service, the terms of the Product or Third-Party Service shall control to the extent of its subject matter.

Some functionality of the Products and Third-Party Services will involve the collection and transmission of information that personally identifies you, including information that we obtain directly from the mobile device owned or otherwise controlled by you ("Mobile Device"). BSJI may use automatic means (including, for example, cookies and web beacons) to collect such information. All information we collect on the MiDi App is subject to our Privacy Policy, available at [<https://en.bsji.com/ps/privacy/>]. By using the MiDi App, you consent to all actions taken by us with respect to your information in compliance with the Privacy Policy. Please review our Privacy Policy and any privacy notice or disclosure relating to a Product or Third-Party Service you apply for or obtain through the MiDi App

for more information about how we or our third-party providers collect, use, and share your Personal Information.

## 2. CHANGES

BSJI may revise and update these Terms of Use from time to time in our sole direction. All changes are effective immediately when we post them and apply to all access to and use of the MiDi App thereafter. Your continued use of the MiDi App following the posting of revised Terms of Use means constitutes your agreement to the changes. You are expected to check review the Terms of Use from time to time so you are aware of any changes, as they are binding on you.

## 3. ELIGIBILITY

Any natural person using the MiDi App must be at least 18 years of age. The MiDi App may only be used outside of the Commonwealth of Puerto Rico. Any use of the MiDi App is at your own risk, and you must comply with all applicable laws, rules and regulations in doing so. We may limit MiDi App's availability at any time and without notice, in whole or in part, to any person, geographic area or jurisdiction that we choose.

## 4. LICENSE GRANT

Subject to the terms herein, BSJI grants you a personal, non-exclusive, and non-transferable license to:

- Download, install, and use of the MiDi App for your personal, non-commercial use on a single Mobile Device strictly in accordance with the MiDi App's documentation; and
- Access, download, and use the products and/or services provided through the MiDi App made available in or otherwise accessible through the MiDi App, strictly in accordance with these Terms of Use.

## 5. RESERVATION OF RIGHTS.

You acknowledge and agree that the MiDi App is provided under license, and not sold, to you. You do not acquire any ownership interest in the MiDi App under these Terms of Use, or any other rights thereto other than to use the MiDi App in accordance with the license granted, and subject to all terms, conditions, and restrictions, under these Terms of Use. BSJI and its licensors and service providers reserve and shall retain their entire right, title,

and interest in and to the MiDi App, including all copyrights, trademarks, and other intellectual property rights therein or relating thereto, except as expressly granted to you in these Terms of Use.

## 6. ACCEPTABLE USE

The MiDi App shall be used only for lawful purposes and in accordance with these Terms of Use. You agree not to:

- Use the MiDi App in a way that violates any applicable federal, state, local, or international law or regulation (including without limitation, any laws regarding the export of data or software to and from the United States or other countries).
- License, sell, resell, re-license, assign, distribute, advertise, exploit, or commercially benefit from the MiDi App, the MiDi brand, tools, or the Products the MiDi App provides.
- Modify or create works based on the software, parts of the software, or the brand of MiDi.
- Reverse engineer, disassemble, decompile, decode, or otherwise attempt to derive or gain access to the source code of the MiDi App or any part thereof, even for academic and/or non-profit purposes.
- Use the MiDi App in any manner that could disable, overburden, damage, or impair the MiDi App or interfere with any other party's use of the MiDi App.
- Use any manual process to monitor or copy any of the material on the MiDi App or for any other unauthorized purpose without our prior written consent.
- Introduce any viruses, trojan horses, worms, logic bombs or other material which is malicious or technologically harmful.
- Attempt to gain unauthorized access to, interfere with, damage or disrupt any parts of the MiDi App, the server on which the MiDi App is stored, or any server, computer or database connected to the MiDi App.
- Use the MiDi App in a way that fails to comply with applicable third party terms or otherwise violates these Terms of Use.

## 7. THIRD PARTY SITES

The MiDi App may contain links to other sites and resources provided by third parties. These links are provided for convenience only. BSJI has no control over the contents of those sites or resources and accepts no responsibility for them or for any loss or damage that may arise from you or any other person's use of them.

## 8. THIRD PARTY SERVICES.

We may, from time to time, make Third Party Services available to you through the MiDi App. Nothing in these Terms of Use shall be deemed to be a representation or warranty by us with respect to any Third-Party Services. We have no obligation to monitor Third Party Services, and we may block or disable access to any Third-Party Services (in whole or part) through the MiDi App at any time.

## 9. UPDATES

BSJI may from time to time develop or provide MiDi App updates, which may include upgrades, bug fixes, patches, other error corrections, and/or new features (collectively, including related documentation, "Updates"). Updates may also modify or delete in their entirety certain features and functionality. You agree that BSJI has no obligation to provide any Updates or to continue to provide or enable any particular features or functionality. Based on your Mobile Device settings, when your Mobile Device is connected to the internet either: (a) the MiDi App will automatically download and install available Updates; or (b) you may receive notice or be prompted to download and install available Updates. You shall promptly download and install all Updates and acknowledge and agree that the MiDi App or portions thereof may not properly operate should you fail to do so. You further agree that all Updates will be deemed part of the MiDi App and be subject to these Terms of Use.

## 10. RIGHT TO SUSPEND OR TERMINATE USE

Subject to applicable law and the terms of any Product or Third Party Service, we reserve the right, in our sole discretion, at any time, for any or no reason, and with or without prior notice, to suspend or terminate your license, your use of the MiDi App (in whole or in part), or any Product or Third party Service made available to you. Upon any such termination, you agree to promptly delete all copies of the MiDi App from any of your Mobile Devices

on which the MiDi App has been installed.

## 11. INTELLECTUAL PROPERTY

The MiDi App and its entire contents, features and functionality (including but not limited to all information, software, text, displays, images, video and audio, and the design, selection and arrangement thereof), are owned, controlled, or licensed to or by BSJI and are protected by United States and international copyright, trademark, patent, trade secret and other intellectual property or proprietary rights laws. The names "BSJI," "Midi" and all related names, logos, product and service names, designs, and slogans are trademarks and/or service marks of BSJI or its affiliates or licensors. You must not use such marks without the prior written permission of BSJI. All other names, logos, product and service names, designs and slogans on the MiDi App are the trademarks of their respective owners.

## 12. DISCLAIMER OF WARRANTIES

You understand that we cannot and do not guarantee or warrant that files available for downloading from the MiDi App will be free of viruses or other destructive code. You are responsible for implementing sufficient procedures and checkpoints to satisfy your requirements for anti-virus protection and accuracy of data input and output, and for maintaining a means external to our site for any reconstruction of any lost data. WE WILL NOT BE LIABLE FOR ANY LOSS OR DAMAGE CAUSED BY A DISTRIBUTED DENIAL-OF-SERVICE ATTACK, VIRUSES OR OTHER TECHNOLOGICALLY HARMFUL MATERIAL THAT MAY INFECT YOUR COMPUTER EQUIPMENT, COMPUTER PROGRAMS, DATA OR OTHER PROPRIETARY MATERIAL DUE TO YOUR USE OF THE MIDI APP OR ANY SERVICES OR ITEMS OBTAINED THROUGH THE MIDI APP OR TO YOUR DOWNLOADING OF ANY MATERIAL POSTED ON THEM, OR ON ANY WEBSITE LINKED TO IT.

You agree to defend, indemnify and hold harmless BSJI, its affiliates, licensors and service providers, and its and their respective officers, directors, employees, contractors, agents, licensors, suppliers, successors and assigns from and against any claims, liabilities, damages, judgments, awards, losses, costs, expenses or fees (including reasonable attorneys' fees) arising out of or relating to your violation of these Terms of Use or your use of the MiDi App, including, but not limited to, any use of the MiDi App's content, services and products other than as expressly authorized in these Terms of Use or your use of any information obtained from the MiDi App.

## 15. GOVERNING LAW

All matters relating to the MiDi App and these Terms of Use and any dispute or claim arising therefrom or related thereto (in each case, including non-contractual disputes or claims), shall be governed by and construed in accordance with the laws of the Commonwealth of Puerto Rico without giving effect to any choice or conflict of law provision.

## 16. WAIVER AND SEVERABILITY

No waiver by BSJI of any term or condition set forth in these Terms of Use shall be deemed a further or continuing waiver of such term or condition or a waiver of any other term or condition, and any failure of BSJI to assert a right or provision under these Terms of Use shall not constitute a waiver of such right or provision.

If any provision of these Terms of Use is held by a court or other tribunal of competent jurisdiction to be invalid, illegal or unenforceable for any reason, such provision shall be eliminated or limited to the minimum extent such that the remaining provisions of the Terms of Use will continue in full force and effect.
